
Online IOSH Approved Managing Safely Course

Course Description

This course is delivered entirely online through 8 hours of videos and exercises. With interactive lessons, practical examples, and flexible, self-paced learning, making it ideal for professionals with busy schedules.

The course can be sat at your own pace though you should expect to take around 24 hours to complete it. You can pause at any point during the course and come back to it anytime over a 190 day period.

The content covers the same syllabus as the 3 Day IOSH Managing Safely classroom course and on passing the online course, you will receive the same certificate as those who sit the classroom course.

Who is this course for?

This IOSH Approved Managing Safely online course is designed to equip managers and supervisors with essential health and safety skills to promote safer workplaces.

Course Content

Key areas covered include hazard identification, risk assessments, incident investigations, and adherence to safety regulations. The modules covered include:

Learning Objectives

By the end of this course, delegates will be able to:

- Understand the importance of their role in managing health and safety in their workplace
- Define key health and safety terms
- Identify hazards and carry out an effective risk assessment in the workplace
- Describe how to identify, measure and control hazards and risks
- Understand their responsibilities in relation to health and safety at work
- List the steps that need to be taken to effectively investigate incidents
- Apply practical steps to measure the effectiveness of health and safety programmes in the workplace

Assessments

The course is assessed in 2 parts:

- Module 8 - A multiple choice examination in which candidates must demonstrate what they have learnt. There are 60 marks available and the pass mark is 36 out of 60 (60%).
- Module 9 - A practical assessment in which participants must show how to apply the knowledge they have gained throughout the course to real life situations. This practical assessment can be filled in online and once complete, it will be sent to an IOSH Approved assessor for marking and feedback. It can take up to 1 week for the assessment to be marked.

Course Books

There are no course books with the Online IOSH Approved Managing Safely course.

Certification

Successful candidates receive an official IOSH Approved Managing Safely Digital Certificate issued by IOSH.

The certificate is sent directly to the delegate who completed the course via the same email address that they used to login to the course. It can take up to 1 week for the Module 9 assessment to be marked. On passing, it can take a further 1 week to receive the digital certificate from IOSH.
